

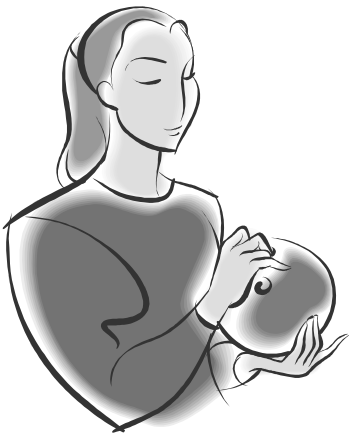

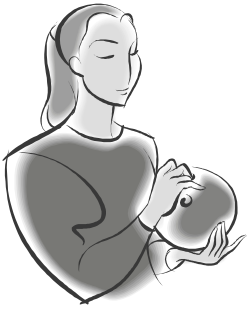

# The 3rd Annual Women's "Invitational" Tournament

## Tournament Rules

**Entry Requirements:** This is a USBC-certified scratch singles invitational bowling tournament open only to female bowlers holding current USBC membership. Invitations are issued to any female bowler who has a USBC-certified bowling average of 180 or higher. Both adult women and junior girls may participate.

**Tournament Format:** Qualifying Round: All bowlers will bowl two, 5-game qualifying rounds (10 games total) moving pairs after each game. The top 8, 12, or 16 bowlers, based on the total 10-game scores from the qualifying rounds, will advance to the Championship Round. 8 bowlers will advance if the field consists of 49 or fewer bowlers. 12 bowlers will advance if the field consists of 50-74 bowlers. 16 bowlers will advance if the field consists of 75 or more bowlers. Tiebreaker: Ties for advancement to the Championship Round will be broken by using the high, single game score(s) rolled in the Qualifying Round. Championship Round: The Championship Round will consist of head-to-head match play between all Championship Round bowlers. The final match will be a position round. A match play win adds 20 bonus pins, a tie adds 10 bonus pins to the bowler's total score. The total score from the 10 Qualifying Round games, added to the match play scores, plus match play bonus pins, will determine the tournament winners. There will be no stepladder finals. The closing date for pre-paid entries is Friday, June 11, 2010 and the closing date for walk-in entries is Sat., June 12, 2010.

**Dress Code/Behavior/Equipment:** Dress Code: Allowed apparel includes pants, capri's, skorts, skirts, and/or walking shorts of appropriate (fingertip) length. Bowling shoes must be worn. Not allowed apparel includes: jeans, hats, halter tops. Bowlers are expected to be dignified and professional in appearance, reflecting the high caliber of tournament bowling anticipated. Behavior: Abuse of equipment, foul or disruptive language/gestures, and/or unprofessional behavior by bowlers or spectators are cause for the non-refundable dismissal from participation or attendance at this tournament. Equipment: All bowling equipment must meet USBC specifications and all equipment is subject to inspection. The use of powder or any foreign substance on shoes, the approach, or on the facility floor or carpet is not permitted. Bowlers may not alter the surface of a bowling ball during competition after the start of any round (ball cleaning allowed per USBC rules). Only participating bowlers and tournament officials are permitted in the bowling area.

**Empowerment:** The Tournament Manager has the right to refuse any entry. The bowler, by voluntary participation in this tournament, acquiesces to the final authority of the Tournament Manager to interpret and enforce all tournament rules, regulations, and procedures. Any unforeseen or not described situation will be regulated by USBC rules with interpretive judgment guided by the best interests of the sport of bowling and this event.

**Awards:** It is guaranteed that all bowlers that advance to the Championship Round will receive a cash/scholarship award. No fewer than 1:6 participants will cash. (In 2008, the payout ratio was 1:4. In 2009, the payout ratio was 1:3). Awards earned by USBC-adult bowlers will be paid by a check mailed to the bowler (at the address on their entry form) within ten (10) days of the completion of the tournament. Awards earned by USBC-junior bowlers will only be paid in the form of a USBC-SMART scholarship (SMART account #8871). Junior bowlers are required to complete the *USBC Prize Waiver* form prior to participation. USBC Rule #400 will be observed. 100% of all collected prize monies will be returned to participants as cash/scholarship awards.

\* Recipients of paid entries are responsible for all other expenses associated with their attendance at this event.

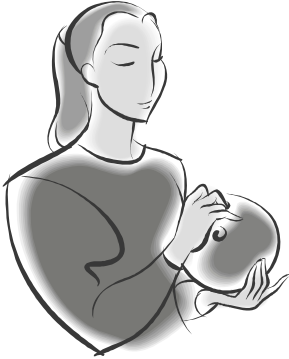
